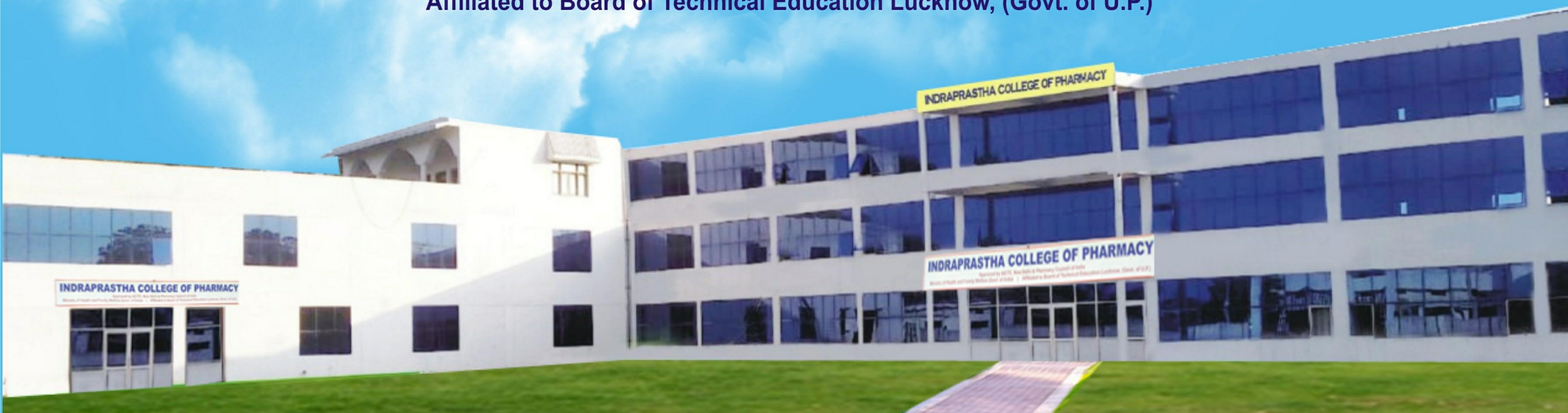

In the academic or professional world, Pharmacy is defined as the branch of science that deals with the preparation, doses, dispensing and effects (including safety) of medicines (or medicinal drugs or simply drugs).

A Pharmacist (one who has got sufficient knowledge of Pharmacy or practises Pharmacy) technically should possess more knowledge than a Medical Doctor regarding medicinal drugs – composition (or formulation) of a drug, effects/interaction with the biological system, physical and chemical properties, therapeutic doses, side-effects, interactions with other drugs.

Besides, pharmacists also play an important role in advising and counselling patients, and prescribing medicines. However, pharmacists are not medical doctors – they do not conduct diagnosis and/or surgeries on patients. Globally Pharmacy is considered as noble as the Medical profession, if not more. ## **Differences between Pharmacy & Pharmaceutical Sciences**

It could be a little bit confusing between Pharmacy and Pharmaceutical Sciences (even I was confused initially). To make things simple – the B.Pharma course is basically a Bachelor program on Pharmaceutical Sciences. You will cover a comprehensive range of major and minor subjects. The major subjects (or modules) are:

### **Human Anatomy & Physiology (Human Biology including Patho-physiology)**

Pharmaceutical Chemistry (including Physical Chemistry, Inorganic Chemistry, Organic Chemistry, Analytical Chemistry and Medicinal Chemistry)

Pharmaceutics (deals with formulation, drug delivery, drug stability, dosage forms, patient acceptance etc.)

Pharmacology (study of effects of drugs on human body and biological systems – mixture of biology, physiology and chemistry; will cover both basic, advanced and clinical pharmacology)

Pharmacognosy (study of medicinal drugs derived from plants; deals with botany, plant science and phyto-chemistry)

Biochemistry (study of biological reactions within living organisms), Microbiology (study of micro-organisms like bacteria, virus, protozoa etc.)

Pharmaceutical Engineering and Technology (deals with basic concepts of Chemical Engineering – e.g. Fluid Dynamics, Process Chemistry and Industrial Processes)

Minor subjects or modules will include – Hospital Pharmacy, Clinical Pharmacy, Immunology, Marketing & Business Management, Electronics & Computer Science (or Applications), Engineering Drawing, Engineering Mathematics, Statistics, Pharmaceutical Biotechnology, Computational Chemistry – this is not a comprehensive list of minor and elective modules.

## Rules & Regulations

1. All the Students must attend the college in proper dress. for Sikh boys Uniform is must. Patkas and loose dresses are not allowed in the college campus during working hours. Students must wear the prescribed uniform during workshop sessions.
2. Every students is required to be disciplined and to have decorous behavior both inside and outside the campus and not to indulge in any activity which will tend to bring down the prestige of the institution.
3. To maintain the sanctity of an educational institution students must not scribble or in any way deface the walls, floors, desks, drawing boards, toilet walls etc.
12. It is the discretion of the Chief Warden to allot/not to allot a room/accommodation to a student on the basis of his/her previous record in the hostel/college.
13. Hostel option is allowed once in an academic year in the month of August and no change of option will be allowed in between the same academic year, except for the students who go out for six months industrial training.
14. Use of electrical gadgets like heaters, electric rod, press, radio, tape-recorder in the hostel is not allowed.
15. Cooking is not allowed in the hostel rooms.
16. Guests are not permitted to reside in the hostel without prior permission of the college warden.
17. Chief warden/warden or any college authorities can inspect any room at any time.

4. Consumption of drugs, alcohol or any other habit forming substance and smoking is strictly prohibited within the premise and hostel.
5. Carrying of weapons of any sort sharp or blunt, is a serious offence and is strictly prohibited.
6. Ragging is strictly banned within the college premises. Any students indulging in ragging will face very severe disciplinary action.
7. Students are expected to cultivate a sense of oneness and belonging with the college and not cause damage to any laboratory equipment, books, furniture, building or any other property of the college.

8. Students are required to keep their mobile phones switched off during the class and in silent mode when outside the class and in silent mode when outside the class but still within the college campus.
9. The name of a student who remains absent for 10 or more days continuously, will be struck off from the college rolls.
10. Students have to appear for all tests conducted for continuous assessment as per the schedule announced.
11. Allotment of hostel rooms is made on the basis of merit of the previous semester.

18. Entry in the hostel will not be allowed beyond 10:30 PM in case of Boys hostels. The timings for girl hostels will be notified by the hostel warden in consultation with the principal.
19. Absence from hostel for the whole night without prior permission from the hostel warden is considered an act of serious misconduct, and carries severe punishment.
20. Students must switch off the lights and fans while leaving the rooms, otherwise penalty will be imposed for wastage of power.
21. The students can keep a PC and lap top in their hostel rooms with the due permission of the Hostel warden/Chief warden.
22. Students are advised no to keep valuables and currency in their rooms, and must lock their cupboards and rooms while going out. College will not be responsible for any loss.

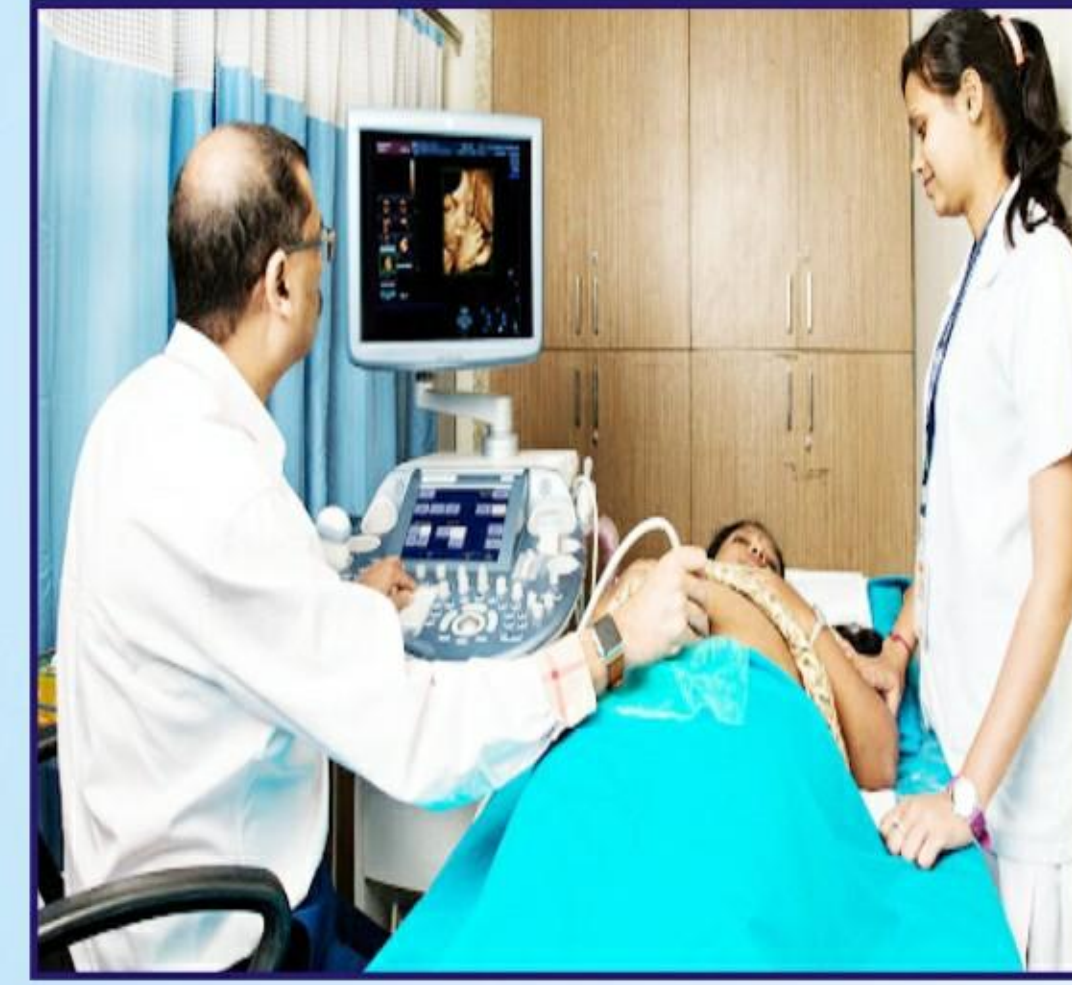
